SHORT FORM PARTICIPATION AGREEMENT

I, _____, understand, acknowledge and agree that I am being considered to be a participant by BBC Worldwide Reality Productions, LLC for a television docu-series for OWN: Oprah Winfrey Network ("Network") currently entitled "Lovetown, USA" (the "Program").

Description of the Program: Over 30 days, an expert team of matchmakers will help a group of single inhabitants from one town find love in their own community. Through a series of dates, interviews, challenges and events, participants will meet potential suitors in the quest to find a perfect partner. The town will support the challenge as a whole, from local authorities to businesses and individuals. Participants will be filmed throughout the 30 day process at home and on location, and will be interviewed about their experience.

For good and valuable consideration, receipt of which is hereby acknowledged, I hereby irrevocably authorize BBC Worldwide Reality Productions and OWN, and their respective parents, affiliates, subsidiaries, licensees, designees, successors and assigns (collectively, "Producer") to make use of my appearance and participation in connection with the Program.

1. **RIGHTS.** Producer shall have the right to tape, film and photograph and otherwise record me, my name, likeness, voice, conversation, statements, appearances and biographical data, which may include previously recorded materials of me (collectively, "Recordings"), and to use and reuse the said Recordings in connection with the Program and any of Producer's productions, including the exhibition, advertising, promotion, or other exploitation, as Producer may desire throughout the universe in perpetuity in any and all media now known or hereafter devised. I expressly waive any and all moral rights, "*droit moral*," and analogous rights, however denominated, in any jurisdiction of the world, which I may have in connection with my appearance and participation. Producer shall have the right to assign all rights herein this Agreement to Producer's licensees and/or Network.

2. **RESULTS AND PROCEEDS.** Producer shall be the exclusive owner of the Recordings and all results and proceeds of my services. Producer shall have no obligation to use the Recordings in connection with the Program. Producer may delete or edit or change or rearrange all or any portion of the Recordings in any manner whatsoever in Producer's sole discretion. Nothing contained in this Agreement shall grant, transfer or convey any right or interest to me in or to any film, stock, negative, disc, element, tape or other material of any kind or nature whatsoever relating to the Program.

3. **PARTICIPATION.** By signing this Agreement, I expressly agree that if I am selected to be a participant in the Program, I agree participate to the full extent reasonably required by Producer. As a condition of my participation in the Program, I hereby agree to execute Producer's standard long form participant agreement and/or Producer's series talent agreement as applicable in Producer's sole discretion. As a further condition of my participation in the Program, I hereby consent to and I will complete whatever documentation required by the entity hired to perform background checks, psychological and medical checks of me (if any) as requested by Producer and/or Network. I understand and acknowledge that Producer and Network will incur significant costs and expenses in reliance upon this Agreement, so I will not nor will I attempt to cancel it or to revoke any of the rights granted to Producer and/or Network in this Agreement.

If selected, I will be available and agree to fully participate in all aspects of the Program (pre-production, production and post-production), which is tentatively scheduled to commence in February 2012 and continue for a period of approximately thirty (30) days; provided, however, production schedule may change, with or without notice to me, in Producer's sole discretion. I agree to fully cooperate with Producer with respect to any changes in the production schedule and I will be reasonably available in the event of such changes.

4. **REPRESENTATIONS AND WARRANTIES.** In consideration of and as inducement to Producer to consider me as a participant in the above-referenced Program, I hereby represent and warrant: (i) that to the best of my knowledge, any statements made by me during my appearance are true and will not violate or infringe upon the rights of any third party; (ii) that I am not a member any other guild, union or collective bargaining agreement associated with the performing arts; (iii) that I did not give or agree to give anything of value to anyone associated in any manner with the Program; (iv) and that I understand that payments for arranging personal appearances and that failure to disclose any such arrangement constitutes a federal crime, unless disclosed to the Producer prior to broadcast.

5. **CONFIDENTIALITY.** I acknowledge and agree that any and all information disclosed to or obtained by myself concerning or relating to the Program, including but not limited to the premise and concept of the Program, the nature of certain events in the Program, my participation in the Program as well as the activities occurring in connection with the Program and the outcome of the Program (collectively, the “Confidential Information”), shall be strictly confidential, and I hereby agree not to disclose any such Confidential Information to any individual or entity. I acknowledge and agree that any disclosure of such Confidential Information is in violation of this Agreement and shall constitute a material breach of this Agreement and shall cause Producer and its employees, contractors, agents, licensees and assigns irreparable injury. I further agree that in the event of any disclosure by myself in violation of this Agreement, I shall be liable to Producer and its employees, contractors, agents, licensees and assigns and I agree that Producer and its employees, contractors, agents, licensees and assigns shall have the right to utilize all available remedies under the law, including both financial and injunctive relief, to seek retribution for any breach of this confidentiality provision. I expressly agree that Producer and its employees, contractors, agents, licensees and assigns shall be entitled to any and all relief available to Producer and broadcasters as reasonable compensation for the significant harm which will be incurred by Producer and its employees, contractors, agents licensees and assigns as a result of any such disclosure and/or breach of this Agreement by myself.

6. **PUBLICITY.** All aspects of the publicity and promotion for the Program shall be at Producer’s and its designee’s sole discretion. During and after taping of the Program, I shall not directly or through any publicity representative or otherwise circulate, publish or otherwise disseminate any news story, article, book or other publicity relating to Producer’s participation in the Program and the subject matter of this release, Producer, or the Program. The foregoing shall not be deemed to prohibit me from issuing publicity that includes incidental references to the Program and my involvement therein, provided the same occurs after the initial press release for the Program has been issued by Producer and does not mention the Program, Producer or any other person or entity involved therewith in an unfavorable or derogatory manner. Without limiting the foregoing in any manner, I acknowledge and agree that I shall not at any time use any of Producer’s broadcast licensee’s names, logos, trade names or trademarks (including, but not limited to, OWN: Oprah Winfrey Network (which includes its agents, affiliates, assigns and/or subsidiaries, either wholly or partially owned), Oprah Winfrey, Oprah, and the title of the Program), or those of any related companies, in connection with any kind of advertising and promotion, publicity, merchandise, tie-in, product or service.

7. **RELEASE OF CLAIMS.** I agree to release, indemnify and hold harmless Producer and all other persons and entities connected with the Program, their respective parents, subsidiaries, affiliates, successors, licensees and assigns of each of the foregoing, and each of their respective officers, directors, employees, agents and representatives from any and all liability, claims, demands, and causes of action of any kind or nature whatsoever, including without limitation defamation, bodily harm, infliction of emotional distress and invasion of privacy, arising out of or in connection with my appearance, statements and/or actions (including use of re-creations) on or in connection with the Program including any costs incurred by Producer in connection therewith. I acknowledge that Producer will rely on this permission at substantial cost, potentially, to Producer and hereby agree not to assert any claim of any nature whatsoever against anyone relating to or arising from the exercise of the permissions granted hereunder.

8. **INDEMNIFICATION.** I agree to indemnify Producer, the sponsors and broadcasters of the Program, now known or hereafter devised, from any and all liability, judgments, claims, losses and expenses (including reasonable attorney’s fees) in connection with any representation, warranties or agreement made by me hereunder.

9. **REMEDY.** I further agree that in no event shall I be entitled to injunctive or equitable relief in connection with this Agreement, and that my rights and remedies shall be limited to the right, if any, to obtain monetary damages at law.

10. **THIRD PARTY BENEFICIARY.** The parties hereby agree that the Network, for the duration of the license term between Producer and the Network, is an intended third-party beneficiary of this Agreement and is entitled to rely upon all rights, representations, warranties and covenants made by Participant to the same extent as Producer’s reliance hereunder.

11. **MISCELLANEOUS.** This agreement constitutes the entire understanding and agreement of the parties, and supersedes all prior understandings, whether written or oral. Should any provision of this agreement be void or unenforceable, such provision shall be deemed omitted, and this agreement with such provision omitted shall remain in full force and effect. This agreement shall be interpreted in accordance with the laws of the State of California. Any litigation, action or proceeding brought by you against Producer arising out of or relating to this agreement shall be instituted only in a state or federal court in the County of Los Angeles, California.
